WATER SOLUBILITY: Insoluble.

APPEARANCE: Yellow, round scored tablets, identified as 54 043

STABILITY: Stable.

CONDITIONS TO AVOID: None.

HAZARDOUS POLYMERIZATION: Will not occur.

SECTION VI - HEALTH HAZARD DATA

EFFECTS OF OVEREXPOSURE: Excess ingestion may lead to nausea, vomiting, and diarrhea, followed by mild leukopenia, and mild abnormalities in liver function.

CARCINOGENICITY: Not listed.

EMERGENCY FIRST AID PROCEDURES:

INGESTION: Obtain emergency medical treatment.

INHALATION: Remove to a well ventilated area.

SKIN CONTACT: Flush with water.

EYE CONTACT: Flush immediately with copious amounts of water for at least 15 minutes. Obtain emergency medical treatment.

SECTION VII - PRECAUTIONS FOR SAFE HANDLING AND USE

SPILL AND DISPOSAL INFORMATION: Clean up spill wearing protective clothing, double latex surgical gloves and eye protection. Clean area by wiping the material with wet absorbent gauze. The spill areas then should be cleaned (three times) using a detergent solution followed by clean water.

Any glass fragments should be placed in a small cardboard or plastic container and then into a Cytotoxic Drug (CD) disposal bag, along with the used absorbent pads and any non-cleanable contaminated items.

Glassware or other contaminated reusable items should be placed in a plastic bag and washed in a sink with detergent by a trained employee wearing double surgical latex gloves.

Disposal of the Azathioprine material should be done by incineration. Dispose of in accordance with Federal, State and Local Regulations.

STORAGE AND HANDLING INFORMATION: Keep out of reach of children. SEE PACKAGE INSERT FOR COMPLETE INSTRUCTIONS AND PRECAUTIONS.

SECTION VIII - SPECIAL PROTECTION INFORMATION

RESPIRATORY PROTECTION: None required.

VENTILATION: Normal room ventilation.
